### **TAKE ACTION FOR EDUCATION FUNDING TELL YOUR SENATOR TO CO-SPONSOR SB750**

Last week, the Senate Education committee approved SB750, sponsored by Senator James Meeks. Thanks to the efforts of Civic Action leaders on Faith in Action Day for Education Funding Reform in Springfield on May 12 and our call-in day last week, the bill now has 21 co-sponsors! The legislative session is scheduled to close this week, so now is the time to call your state Senator and ask them to co-sponsor and pass SB750 to ensure that all children in Illinois have the opportunity for a quality education.

#### **Some more facts about SB750:**

- SB750 would increase the state income tax from 3% to 5% and expand the sales tax base to include the sale of non-essential services - Illinois would still have the third-lowest income tax of any state that utilizes an income tax.
- The funds raised would be used to fully fund the Education Funding Advisory Board (EFAB) foundation level of funding for the first time.
- The state currently under-funds EFAB by more than \$1,300 per student per year.

### **Pay Day Loan Reform Update**

*This information is from Emily Stuard of Citizen Action Illinois, working with religious leaders to help place legal limits on the payday loan industry, which takes advantage of some of our most economically vulnerable fellow citizens.*

The Consumer Installment Loan Reform Act, SB 1435, did not pass out of the House Executive Committee. Please read the press release below for more information. The press release is also attached.

### **Consumer Protections Defeated in House Executive Committee** *Predatory Lenders Stall Efforts to Stop Usury in Illinois*

The Consumer Installment Loan Reform Act (SB 1435) was defeated in the House Executive Committee on Tuesday night with one aye vote, two nay votes, and **eight present votes**. SB 1435 would have ensured that all Illinoisans have access to credit with reasonable rates and protections to guard against the cycle of debt.

“The Consumer Installment Loan Reform Act was the result of over a year of numerous open meetings between consumer advocates and industry players,” said Tom Feltner of the Woodstock Institute. “The proposal represented a reasonable direction – balancing the need to offer longer-term, small consumer installment loans in Illinois.”

SB 1435 defined within the Consumer Installment Loan Act a “small consumer installment loan” with a principal of \$4,000 or less and interest rates below 99% APR. The Act also closed a glaring loophole in the Payday Loan Reform Act, which has allowed lenders to evade guaranteed consumer protections, by limiting interest rates to 36% APR on loans above \$4,000. Additionally, the Consumer Installment Loan Reform Act would have capped monthly payments for a “small consumer loan” at 20% of the borrower's monthly income and required lenders to report loan information into a consumer database for purposes of determining borrower eligibility.

“Following a year of good-faith negotiations, the Governor’s Office, Attorney General’s Office, and the Egan Campaign successfully won the support of all the major installment lenders in Illinois, as well as half of the payday lending industry represented by the Community Financial Services Association,” said Lynda DeLaforge of Citizen Action/Illinois. “However, the portion of the lending industry, which philosophically opposes reasonable rate caps, soundly defeated the pro-consumer proposal in the Executive Committee last evening.”

“Last night’s devastating defeat means that working families in Illinois for at least another year will be preyed upon by high-cost, long-term loan products, which trap borrowers’ in an endless debt cycle,” said Suzanne Strassberger of Metropolitan Family Services. “Due to the inaction of the House Executive Committee, consumers will continue facing loans with interest rates ranging upwards of 1000% APR without any consumer protections.”

“The Illinois House Executive Committee voted with a small, but well-connected segment of the lending industry – maintaining the status quo,” said William McNary of Citizen Action/Illinois. “The working families of Illinois, who are currently trapped in triple-digit interest rate loans, lost today, but their time is coming. We are confident that with the support of a strong consumer coalition, including State Representative Hamos, State Senator Lightford, Governor Quinn, Attorney General Madigan, and major segments of the payday and installment lending industries, consumers will prevail. We urge five more members of the Executive Committee to vote for the bill and give their colleagues an opportunity to vote.”

### ***Longtime National Ministries Staff Member, Richard Jones, Dies***

**VALLEY FORGE, PA (ABNS 5/12/09)**—Dr. Richard M. Jones, who retired as deputy executive director in 1991 after 36 years of service to American Baptist National Ministries, died on Friday, May 8, following a fall several days earlier. He was 81.

During his more than three decades of ministry at National Ministries, he also served as director of planning and secretary to the board of directors; he held leadership positions in the Office of Policy Development and the Division of Evangelism as well, where he became engaged with the Baptist Jubilee Advance (1959–1964). This loose collaboration of several Baptist bodies planned evangelism strategies in the context of movements for social justice.

As part of that work, Jones participated in the Civil Rights Movement, walking in the March on Washington in 1963. Jones wrote of that event: “We...gathered at the First Baptist Church of Washington, D.C., for a short prayer service and then joined thousands of others to walk toward the Lincoln Memorial for a time of music and the famous ‘I Have a Dream’ speech by Dr. King. I was fortunate to be close to the platform and hear those words and feel the power of them.”

On the occasion of his 80th birthday last year, Jones wrote of a 1963 meeting with Dr. King and other social justice advocates to plan strategies for taking stands against injustice: “There was a sense of emergency, fear and authenticity to the relationship of faith with action. Dr. King...had a sense of what might befall the movement as it took shape.”

Jones engagement in the Civil Rights Movement, he wrote, transformed his theological understanding and commitment along with his belief that personal salvation and action for social justice are intertwined. “Dick Jones helped shape the ministry and mission of home mission for more than a quarter of a century,” says Dr. Aidsand F. Wright-Riggins III, National Ministries’ executive director. “He was particularly adept at planning and making the connection between evangelism and ministries of emancipation. He was an encourager who led National Ministries in its mission of encouraging life in Christ. Dick Jones was a great American Baptist who will be deeply missed.”

Out of the Baptist Jubilee Advance experience grew Metropolitan Associates of Philadelphia (MAP), a lay ministry laboratory, of which Jones was a founder. The ecumenical endeavor, an experimental action-research project, explored new forms of mission in and through urban institutions by drawing together small groups of individuals engaged in sectors of business, medicine, social work, politics, the arts and education to examine what it meant to live out Christian life in the “real life” of the city.

Dr. A. Roy Medley, general secretary for ABCUSA, said, “Working with Dick, there was no room for sloppy thinking or theology. He pressed us to think our best, to reach deep into our faith and how it challenged and had transformative power for our culture. His prophetic voice will be greatly missed.” Jones authored several books, including *The Man for All Men*, a lay study book, along with *Witness Through the Arts and Evangelistic Life Style Awareness Manual*, among others. Prior to his work with National Ministries, Jones held pastorates in Sumner, WA, and Medford, OR.

Jones earned his master of divinity degree with honors at Berkeley Divinity School, now American Baptist Seminary of the West (ABSW) in Berkeley, CA, and did graduate work at Union Theological Seminary and the New School for Social Research, both in New York City. He was a cum laude graduate of Linfield College in McMinnville, OR. ABSW awarded him an honorary doctorate in 1988.

Jones is survived by his widow, Shirley; a daughter, Cheryl; a son, Kimball; and seven grandchildren. Shirley Jones served the Board of Educational Ministries, American Baptist Churches USA, as executive

director of the division of Christian Higher Education, and Colgate Rochester Divinity School as interim president.

A memorial gathering, "A Celebration of Life and Service," will be held on Saturday, May 23, at 2 p.m. at Lakeshore Avenue Baptist Church, 3534 Lakeshore Ave., Oakland, CA, where Jones was a member, Condolences can be sent to Shirley Jones at 1300 Quarry Court #405, Point Richmond, CA 94801.
